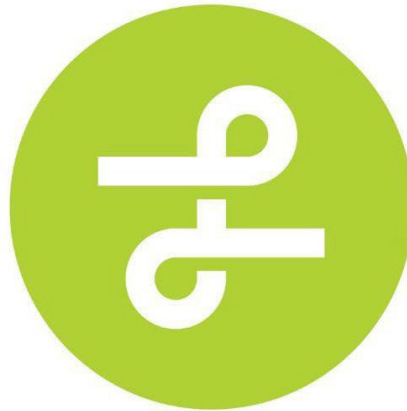

INTRODUCTION

This call for projects is for the 2024 Enhanced Mobility for Seniors and Individuals with Disabilities Program (Section 5310). This funding application includes information on funding availability, project eligibility, the application timeline, the application process, and the project evaluation criteria. The Transit Authority of Lexington-Fayette Urban County Government (Lextran) is the designated recipient for 5310 funding in the Lexington-Fayette County Urban County area. As the designated recipient, Lextran is responsible for developing a 5310 Program Management Plan and administering a Call for Projects for the available funding. Interested applicants should review the Lextran 5310 Program Management Plan and this Call for Projects to determine if they are eligible.

FUNDING AVAILABILITY

The funding amount available for FFY 2022 is \$173,738 and for FFY 2023 the amount available is \$176,572, which means the total federal funding amount is \$350,483, with a required 20 percent match. The entirety of these funds or any funding less than this amount can be applied for in direct relation to local match requirements and project objectives.

PROJECT ELIGIBILITY

Section 5310 funds are available for capital and operating expenses to support the provision of transportation services to enhance the specific needs of seniors and individuals with disabilities. All projects must be situated in the Lexington-Fayette Urban County area and must fulfill a need identified in the Coordinated Plan. Potential project focus should include:

- Public transportation projects planned, designed, and carried out to meet the special needs of seniors and individuals with disabilities when public transportation is insufficient, inappropriate, or unavailable;
- Public transportation projects that exceed the requirements of the ADA;
- Public transportation projects that improve access to fixed route service and decrease reliance by individuals with disabilities on ADA complementary paratransit service;
and
- Alternatives to public transportation that assist seniors and individuals with disabilities with transportation.

Such projects must be targeted toward meeting the transportation needs of seniors and individuals



with disabilities, although the projects may be used by the general public. It is not sufficient that seniors and individuals with disabilities are included (or assumed to be included) among the people who will benefit from the project. The Federal Transit Administration (FTA) encourages projects that are open to the public as a means of avoiding unnecessary segregation of services.

SECTION 5310 PROJECT EXAMPLES

- Travel training
- Volunteer driver programs
- Building an accessible path to a bus stop, including curb-cuts, sidewalks, accessible pedestrian signals or other accessible features
- Improving signage, or way-finding technology
- Incremental cost of providing same day service or door-to-door service
- Purchasing vehicles to support new accessible taxi, rides sharing and/or vanpooling programs
- Mobility management programs

FEDERAL SHARE OF COSTS AND LOCAL MATCH

Section 5310 funds may be used to finance capital and operating expenses. The federal share of eligible capital costs shall be in an amount equal to 80 percent of the net cost of the program. The federal share of the eligible operating costs may not exceed 50 percent of the net operating costs of the activity. Recipients may use up to 10 percent of their apportionment to support program administrative costs including administration, planning, and technical assistance, which may be funded at 100 percent federal share.

After a project application has been selected by the review committee for funding, Lextran will notify



and coordinate with the applicant to submit the necessary FTA documentation.

PROJECT EVALUATION CRITERIA

The following criteria will be followed in determination of funding:

Project Needs (20 points)

Project applications should clearly state the need for the project and demonstrate how the project is consistent with the objectives of the grant program. The project application should indicate how the project will enhance transportation for the urbanized area's senior and disabled populations. The connection between the project and the Coordinated Plan should be clearly described in the application.

Project Planning and Implementation (20 points)

For all projects, applicants must provide a well-defined service operation plan and/or capital procurement plan and describe the implementation steps and timelines for carrying out the plan. The applicant's plan should include coordination, eligibility determination, marketing, and service delivery details.

Project Budget and Grants Management (15 points)

Applicants must submit a complete project budget, indicating anticipated project expenditures and revenues, including documentation of matching funds. The application should address long-term efforts and identify potential funding sources for sustaining the service beyond the grant period.

Program Effectiveness and Evaluation (20 points)

The project will be scored based on the applicant's identification of clear, measurable, outcome-based performance measures, including customer satisfaction, to track the effectiveness of the service. The applicant should monitor and evaluate the service throughout the period of performance.

Organizational Preparedness and Technical Capacity (25 points)

Projects should be a good fit in the applicant's organization. The applicant must demonstrate that it has staff with the technical experience to manage or operate a transportation service, such as correct levels of insurance for operations. In addition, the applicant must show that they are prepared to monitor and provide safe services.
